

SISYFLY PERFORMANCE BASED TERMS

1. SISYFLY will send out an invoice within 7 (seven) days of score receipt following each American College Testing (ACT) administration. Payment will be due within 14 (fourteen) days of the invoice date. **Failure to pay the invoice within 14 (fourteen days) will result in a \$100.00 late fee and further legal action.**
2. **Example scenario: A student begins with a baseline score of 20 and earns a 23 on his or her first ACT test. \$2400 would be due. On the next test, the same student earns a 25 super-score. An additional \$1300 would be due. On the third take, the same student earned a 27 super-score. An additional \$1000 would be due. The total price for this 7-point increase would be \$4700.**
3. Client insures his or her child will take *at least three* (3) administrations of the American College Testing (ACT) within 12 months of commencing the services provided by Sisyfly.
4. **Failure to sit for three (3) administrations of the American College Testing (ACT) within 12 months of commencing services with Sisyfly will result in a \$1000 early termination fee. Fee would be due within 14 days of invoice date. Failure to pay fee will result in legal action.**
5. Client will be responsible for registering on time, all fees, and other payments associated with taking the American College Testing (ACT).
6. SISYFLY has the right to terminate services at any time without cause.
