## SISYFLY PERFORMANCE BASED TERMS

1. SISYFLY will send out an invoice within 7 (seven) days of score receipt following each SAT administration. Payment will be due within 14 (fourteen) days of the invoice date. Failure to pay the invoice within 14 (fourteen days) will result in a $\mathbf{\$ 1 0 0 . 0 0}$ late fee and further legal action.
2. Example scenario: A student begins with a baseline score of $\mathbf{1 3 0 0}$ and earns a 1380 on his or her first SAT test. \$2200 would be due. On the next test, the same student earns a 1440 super-score. An additional $\$ 2000$ would be due. On the third take, the same student earned a 1500 super-score. An additional $\$ 1300$ would be due. The total price for this 200-point increase would be $\$ 5500$.
3. Client insures his or her child will take at least three (3) administrations of the SAT within 12 months of commencing the services provided by Sisyfly.
4. Failure to sit for three (3) administrations of the SAT within $\mathbf{1 2}$ months of commencing services with Sisyfly will result in a $\$ 1000$ early termination fee. Fee would be due within $\mathbf{1 4}$ days of invoice date. Failure to pay fee will result in legal action.
5. Client will be responsible for registering on time, all fees, and other payments associated with taking the SAT.
6. SISYFLY has the right to terminate services at any time without cause.
